

# 「大學聯合招生辦法」

## 「大學聯合招生辦法」簡介

「大學聯合招生辦法」（簡稱「大學聯招辦法」）旨為持有往屆及／或應屆香港中學文憑考試成績的學生提供申請入讀以下課程的主要途徑：

### 大學教育資助委員會（教資會）資助課程

- 由下列8所教資會資助院校提供的全日制學士學位課程：
  - 香港城市大學（城大）
  - 香港浸會大學（浸大）
  - 嶺南大學（嶺大）
  - 香港中文大學（中大）
  - 香港教育大學（教大）
  - 香港理工大學（理大）
  - 香港科技大學（科大）
  - 香港大學（港大）；
- 由城大提供的教資會資助全日制副學士學位課程；
- 由教大提供的教資會資助全日制高級文憑課程；
- 由理大提供的教資會資助全日制高級文憑課程；

### 自資課程

- 由香港公開大學（公大）提供的自資全日制學士學位課程；及

### 指定專業／界別課程資助計劃（SSSDP「資助計劃」）課程

- 由SSSDP「資助計劃」院校提供的SSSDP「資助計劃」全日制學士學位課程。

申請人只需遞交一份申請，即可申請入讀以上課程。

「大學聯招辦法」並不適用於上述（1）段所列由8所教資會資助院校提供的兼讀制及自資課程，（5）及（6）段所列由公大及SSSDP「資助計劃」院校非經「大學聯招辦法」提供的課程。有關的9所「大學聯招辦法」參與院校（即城大、浸大、嶺大、中大、教大、理大、科大、港大及公大）及SSSDP「資助計劃」院校會樂意解答有關該等課程的查詢。

## 符合「大學聯招辦法」申請資格

下列持有往屆及／或應屆香港中學文憑考試成績及於遞交「大學聯招辦法」申請時**並非**正在修讀經「大學聯招辦法」可選報的全日制學士學位課程的申請人方**符合**透過「大學聯招辦法」遞交申請的資格：

### 1. 只持有香港中學文憑考試成績的申請人

所有申請人（在校及非在校申請人）若希望憑**香港中學文憑考試成績**申請入讀由8所教資會資助院校提供的教資會資助全日制學士學位課程、由公大提供的自資全日制學士學位課程、由SSSDP「資助計劃」院校提供的SSSDP「資助計劃」全日制學士學位課程、由城大提供的教資會資助全日制副學士學位課程及由教大和理大提供的教資會資助全日制高級文憑課程，**必須**透過「大學聯招辦法」遞交申請。於評核「大學聯招辦法」申請過程中，申請人的**香港中學文憑考試成績**將會作為主要考慮因素，而其他因素亦會按需要作為考慮之列。

## 2. 同時持有香港中學文憑考試及其他學術成績的申請人

同時持有香港中學文憑考試及其他學術成績的申請人，而單憑其香港中學文憑考試成績已符合經「大學聯招辦法」可選報的課程申請資格，可選擇透過「大學聯招辦法」或非「大學聯招辦法」途徑遞交申請，惟**不能**同時透過兩種途徑遞交申請。於評核「大學聯招辦法」申請過程中，申請人的**香港中學文憑考試成績**將會作為主要考慮因素，而其他因素亦會按需要作為考慮之列。

## 不符合「大學聯招辦法」申請資格

下列類別之申請人，**不符合**透過「大學聯招辦法」遞交申請的資格：

### 3. 正在修讀經「大學聯招辦法」可選報的全日制學士學位課程的申請人

正在修讀經「大學聯招辦法」可選報的全日制學士學位課程的申請人，不論是否希望憑香港中學文憑考試成績申請入學，均**不符合**透過「大學聯招辦法」遞交申請的資格。

若申請人透過「大學聯招辦法」遞交申請，必須向正在就讀的「大學聯招辦法」參與院校 / SSSDP「資助計劃」院校辦理退學手續。

### 4. 需要合併香港中學文憑考試及其他學術成績的申請人

需要**合併**香港中學文憑考試及其他學術成績方符合經「大學聯招辦法」可選報的課程申請資格的申請人，並**不符合**透過「大學聯招辦法」遞交申請的資格，該申請人應向個別院校查詢有關詳情。

### 5. 未持有任何香港中學文憑考試成績的申請人

未持有往屆香港中學文憑考試成績及不會參加應屆香港中學文憑考試的申請人，均**不符合**透過「大學聯招辦法」遞交申請的資格。

### 6. 只持有其他學術成績的申請人

只持有其他學術成績的申請人，並**不符合**透過「大學聯招辦法」遞交申請的資格。

若申請人屬於以上（3）至（6）類別人士不應透過「大學聯招辦法」遞交申請。若申請人遞交了「大學聯招辦法」申請，其申請將**不獲處理**。任何已繳交的費用，概不退還，亦不得轉作其他年度申請 / 其他申請之用。

若上述申請人希望遞交入學申請，應向個別院校查詢有關詳情。

遞交「大學聯招辦法」申請前，申請人應確定已**符合**「大學聯招辦法」申請資格。任何已繳交的費用，概不退還，亦不得轉作其他年度申請 / 其他申請之用。

## 多重申請

同時持有香港中學文憑考試及其他學術成績的申請人，若單憑其香港中學文憑考試成績或其他學術成績已符合經「大學聯招辦法」可選報的課程申請資格，可選擇：

- 憑香港中學文憑考試成績透過「大學聯招辦法」遞交申請**或**
- 憑其他學術成績透過非「大學聯招辦法」途徑遞交申請。

惟此等申請人**不能**於同一學年**同時**透過「大學聯招辦法」及非「大學聯招辦法」途徑遞交申請入讀經「大學聯招辦法」可選報的任何課程。申請人**必須**取消其中一項之申請，否則其申請將不獲處理。

## 香港中學文憑考試成績

「大學聯招處」、9所「大學聯招辦法」參與院校及SSSDP「資助計劃」院校將從香港考試及評核局（簡稱香港考評局）索取申請人**所有**往屆及 / 或應屆的香港中學文憑考試成績（包括成績評審證明書）。

申請人須於遞交申請時，透過「大學聯招辦法」網上申請系統「Declaration（聲明）」版面授權「大學聯招處」、9所「大學聯招辦法」參與院校及SSSDP「資助計劃」院校向香港考評局索取，及就香港考評局對之發放有關成績，作為審理申請人入學申請之用。因此，申請人無須遞交往屆及 / 或應屆的香港中學文憑考試成績至「大學聯招處」。

惟請注意，申請人於「大學聯招辦法」帳戶內所登記的香港身份證號碼 / 護照號碼（只適用於未持有香港身份證人士）**必須**與其於香港考評局申請香港中學文憑考試時所登記的香港身份證號碼 / 護照號碼**完全相同**。申請人若曾以不同的身份證明文件報考不同年度的香港中學文憑考試，必須**立即**通知「大學聯招處」。否則，「大學聯招處」、9所「大學聯招辦法」參與院校及SSSDP「資助計劃」院校將**不能**向香港考評局索取申請人**所有**往屆及 / 或應屆的香港中學文憑考試成績。由於9所「大學聯招辦法」參與院校及SSSDP「資助計劃」院校未能查閱該等申請人所有的香港中學文憑考試成績，故此其申請或會因而受影響。

申請人須於2016年12月中旬起登入其「大學聯招辦法」帳戶以確認「大學聯招處」、9所「大學聯招辦法」參與院校及SSSDP「資助計劃」院校向香港考評局索取申請人曾應考及 / 或將應考香港中學文憑考試成績的年份是否正確無誤。

由於劍橋國際考試委員會 / 香港考評局就香港中學文憑考試丙類：其他語言科目（6月）考試（丙類（6月）考試）作出的改動，因此，由2017年度起的「大學聯招辦法」申請，9所「大學聯招辦法」參與院校及SSSDP「資助計劃」院校將不會考慮申請人於同一年度考獲的丙類（6月）考試成績。

9所「大學聯招辦法」參與院校及SSSDP「資助計劃」院校於評核入學申請時或會考慮申請人於不同年度考獲的香港中學文憑考試成績。因此，申請人應詳閱個別院校的一般入學條件及個別課程的入學規定。

# JUPAS

## Introduction of JUPAS

Joint University Programmes Admissions System (JUPAS) is a scheme and the main route of application designed to assist students with Hong Kong Diploma of Secondary Education (HKDSE) Examination results (past and / or current) to apply for admission to the following programmes:

### **University Grants Committee (UGC)-funded Programmes**

1. UGC-funded full-time bachelor's degree programmes offered by the following 8 UGC-funded institutions:
  - City University of Hong Kong (CityU)
  - Hong Kong Baptist University (HKBU)
  - Lingnan University (LingnanU)
  - The Chinese University of Hong Kong (CUHK)
  - The Education University of Hong Kong (EdUHK)
  - The Hong Kong Polytechnic University (PolyU)
  - The Hong Kong University of Science and Technology (HKUST)
  - The University of Hong Kong (HKU);
2. UGC-funded full-time associate degree programmes offered by CityU;
3. UGC-funded full-time higher diploma programme offered by EdUHK;
4. UGC-funded full-time higher diploma programmes offered by PolyU;

### **Self-financing Programmes**

5. self-financing full-time bachelor's degree programmes offered by The Open University of Hong Kong (OUHK); and

### **Study Subsidy Scheme for Designated Professions / Sectors (SSSDP) Programmes**

6. SSSDP full-time bachelor's degree programmes offered by the SSSDP institutions.

Applicants need to submit only **ONE** application to apply for admission to all of the above programmes.

Part-time and self-financing programmes offered by the 8 UGC-funded institutions as listed in 1 above, and all other programmes not offered under JUPAS by OUHK and the SSSDP institutions as listed in 5 and 6 above, however, are not covered under the JUPAS scheme, and applicants should apply to the individual institutions directly. The 9 JUPAS participating-institutions (*viz.* CityU, HKBU, LingnanU, CUHK, EdUHK, PolyU, HKUST, HKU and OUHK) and the SSSDP institutions concerned would be pleased to answer enquiries in respect of such programmes.

## Eligible to Apply via JUPAS

The following applicants with past and / or current HKDSE Examination results are **ELIGIBLE** to apply via JUPAS provided that they are **NOT** enrolled in full-time bachelor's degree programmes offered under JUPAS at the time they submit their JUPAS applications:

### **1. Applicants with HKDSE Examination results only**

All applicants (school and non-school applicants) who wish to apply for admission to the UGC-funded full-time bachelor's degree programmes offered by the 8 UGC-funded institutions, self-financing full-time bachelor's degree programmes offered by OUHK, the SSSDP full-time bachelor's degree programmes offered by the SSSDP institutions, the UGC-funded full-time associate degree programmes offered by CityU, and UGC-funded full-time higher diploma programmes offered by EdUHK and PolyU **on the strength of their HKDSE Examination results SHOULD** apply via JUPAS. Assessment of such applicants applying via JUPAS will be based **mainly on their HKDSE Examination results**, while other factors will be considered as appropriate.

**2. Applicants with both HKDSE Examination AND other academic results**

Applicants with both HKDSE Examination **AND** other academic results whose HKDSE Examination results **ALONE** will make them eligible for application for admission to the programmes offered under JUPAS can apply either via JUPAS or non-JUPAS, but **NOT** both. Assessment of such applicants applying via JUPAS will be based **mainly on their HKDSE Examination results**, while other factors will be considered as appropriate.

**NOT Eligible to Apply via JUPAS**

Applicants who belong to one of the following categories are **NOT ELIGIBLE** to apply via JUPAS:

**3. Applicants who are currently enrolled in full-time bachelor’s degree programmes offered under JUPAS**

Applicants who are currently enrolled in full-time bachelor’s degree programmes offered under JUPAS, regardless of whether they wish to apply for admission on the strength of their HKDSE Examination results, are **NOT ELIGIBLE** to apply via JUPAS.

If they apply via JUPAS, they will be required to withdraw from the JUPAS participating-institutions / the SSSDP institutions.

**4. Applicants with a combination of HKDSE Examination AND other academic results**

Applicants with a combination of HKDSE Examination **AND** other academic results which **TOGETHER** may make them eligible for application for admission to the programmes offered under JUPAS are **NOT ELIGIBLE** to apply via JUPAS. They should consult individual institutions concerned for further information.

**5. Applicants without any HKDSE Examination results**

Applicants who do not have any past HKDSE Examination results, nor will be sitting for the HKDSE Examination of the current cycle are **NOT ELIGIBLE** to apply via JUPAS.

**6. Applicants with other academic results only**

Applicants with other academic results only are **NOT ELIGIBLE** to apply via JUPAS.

Applicants who belong to 3 – 6 above should not apply via JUPAS. If they do, their JUPAS applications will **NOT** be processed. Any fees paid will not be refunded or transferred to another year / other application.

If they wish to apply for admission, they should consult individual institutions concerned for further information.

Applicants should ensure that they are **ELIGIBLE** to apply via JUPAS before submitting their JUPAS applications. Any fees paid will not be refunded or transferred to another year / other application.

**Concurrent Applications**

Applicants with both HKDSE Examination **AND** other academic results and whose HKDSE Examination results or other academic results alone would make them eligible for application for admission to the programmes offered under JUPAS can apply

**EITHER:** via JUPAS on the strength of their HKDSE Examination results

**OR:** via non-JUPAS on the strength of their other academic results.

These applicants, however, **CANNOT** apply for admission via **BOTH** JUPAS and non-JUPAS to any programmes offered under JUPAS in the same academic year. They **MUST** cancel either their JUPAS or non-JUPAS applications before they can proceed further.

**HKDSE Examination Results**

**ALL** past and / or current HKDSE Examination results (including Aegrotat Certificates as applicable) obtained by applicants will be obtained from the Hong Kong Examinations and Assessment Authority (HKEAA) by the JUPAS Office, the 9 JUPAS participating-institutions and the SSSDP institutions.

In this regard, applicants are required, at the time of application, to authorise, via the JUPAS online application system at the "Declaration" page, the JUPAS Office, the 9 JUPAS participating-institutions and the SSSDP institutions to obtain, and the HKEAA to release, their results concerned in support of their applications. As such, applicants are not required to submit their HKDSE Examination results to the JUPAS Office.

However, the HKID card numbers / passport numbers (for applicants who do not have HKID cards) which the applicants have used to register at their JUPAS accounts **MUST BE IDENTICAL** to those used to register for their HKDSE Examination at the HKEAA. Applicants who have used different identity documents to register at different sittings in the HKDSE Examination must notify the JUPAS Office **IMMEDIATELY**. If they fail to do so, the JUPAS Office, the 9 JUPAS participating-institutions and the SSSDP institutions will **NOT** be able to obtain **ALL** the HKDSE Examination results (past and / or current) of the applicants concerned from the HKEAA. In such cases, these applications may be disadvantaged since the 9 JUPAS participating-institutions and the SSSDP institutions would not be able to review all the applicants' sittings in their HKDSE Examination.

Applicants are required to confirm their years of HKDSE Examination results the JUPAS Office, the 9 JUPAS participating-institutions and the SSSDP institutions obtained / to be obtained from the HKEAA from mid-December 2016 in their JUPAS accounts.

Due to the change in examination arrangements for HKDSE Examination Category C: Other Language Subjects (June Series) (Category C (Jun Series)) by the Cambridge International Examinations (CIE) / the HKEAA, applicants in the 2017 cohort and beyond who sit for Category C (Jun Series) in the same cycle year, such results will **NOT** be considered by the 9 JUPAS participating-institutions and the SSSDP institutions in time for the 2017 and subsequent JUPAS applications.

The 9 JUPAS participating-institutions and the SSSDP institutions may consider the HKDSE Examination results obtained by the applicants in different sittings when assessing their eligibility for admission. In this regard, applicants should consult the general entrance requirements and individual programme requirements of the respective institutions for further information.

### JUPAS Office
